## **General Price List**

***Prices are effective October 2025 and are subject to change without notice***

The goods and services shown on this price list are those we can provide to our customers. You choose only the items you desire. However, any funeral arrangements you select include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. The items listed on this price list are those services specifically required to be listed by the United States Federal Trade Commission for the protection of the consumer.

### **1. Basic Services of Funeral Director and Staff **\$1495.00****

Our basic service charge includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family or other responsible party; preparation and filing of necessary certificates and permits; shelter of remains for up to three days; planning of funeral arrangements; and coordination of service with cemetery, crematory, vault companies and others as required. Also included in this charge are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs, and equipment and inventory expenses. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select.

(Please note this fee is already ***included*** in our charges for direct cremation, Hydromation®, immediate burial, and forwarding or receiving of remains. See items 18,19, 22, 22a, & 23)

## **2. Embalming**

**\$595.00\*\***

Except in certain special cases, the law does not require embalming. If you select certain funeral arrangements, such as a funeral with viewing, and you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for the embalming. Direct cremation and immediate burial do not involve a public viewing of the remains and therefore would not need embalming. However, both may be accompanied by a funeral service.

## **3. Other Preparation of the Body**

Dressing, basic cosmetic work and placement in casket **\$195.00**

Extensive cosmetic restoration - per hour **\$100.00**

Ceremonial Washing and/or Dressing **\$375.00**

This charge does not include visitation, rites, or ceremonies prior to forwarding of the body or shipping or combo tray (required by airlines).	
<b>19. Receiving of Remains from another Funeral Home</b>	<b>\$1295.00</b>
This charge includes temporary shelter of remains, basic services of staff and transportation of remains to cemetery or crematory. This charge does not include visitation, rites or ceremonies.

## 22. Direct Cremations

**\$1495.00 to \$3,630.00**

A direct cremation is one that occurs without any formal viewing of the remains or any visitation or ceremony with the body present. Our charge for a direct cremation includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; transportation to crematory; all necessary authorizations, permits and paperwork; cremation and the basic container that will hold the cremated remains. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The container we provide is a wood tray with a cardboard top.

This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to burial or the price of the casket, outer burial container or cemetery costs.
